RULES AND REGULATIONS

1. This tournament is certified by USBC, certification #05298. Entry is open to **all USBC adult members** with a **2019-2020 local membership** in the **4- Rivers USBC Association**.
 - a. Competition will be conducted in handicapped **TEAM, DOUBLES** and **SINGLES** events at Oasis Lanes 120 Dell Centre Way, Union. (636)583-2695.
 - b. **TEAM squads** are to be held at **1:00 pm on Saturdays and 9:30 am on Sundays**
 - c. **SINGLES and DOUBLES squads** are to be held at **4:00 pm on Saturdays and 1:30 pm on Sundays**
 - d. **Additional squads may be added, or deleted, if needed, at the Tournament Director's discretion** and will be posted on the **www.4riversusbc.com** website.
2. The **TEAM** event will be three (3) games bowled by a team of either a four (4) or five (5) adult bowlers (male, female or mixed) in two (2) Divisions for each four (4) and five (5) man teams. Teams with averages totaling **735/920 or less** will bowl in the **TEAM Division 1**. Teams with averages totaling **736/921 or higher** will bowl in the **TEAM Division 2**. The **DOUBLES** event will be three (3) games bowled by a team of two (2) adult bowlers (male, female or mixed) in two (2) divisions. Doubles with averages totaling **365 or less** will bowl in the **DOUBLES Division 1**. Doubles with averages totaling **366 or higher** will bowl in **DOUBLES Division 2**. The **SINGLES** event will be three (3) games bowled by adult bowlers (male and female) in two (2) divisions. Bowlers with an average of **185 or less** will bowl in the **SINGLES Division 1**. Bowlers with an average of **186 or higher** will bowl in the **SINGLES division 2**.
3. **OPTIONAL EVENTS. TEAM, DOUBLES and SINGLES entries may elect** to be included in the optional **SCRATCH** events. Entries **MUST BE** entered in the handicap Events to be eligible. The bowlers' scratch scores bowled during the handicap Events will be used for the **SCRATCH** events. A bowler may also elect to participate in the optional **ALL-EVENTS** using the bowler's first Handicap and/or Scratch scores bowled in the Team, Doubles and Singles events. These optional **SCRATCH** and **ALL-EVENTS** events **WILL NOT** have separate divisions based on bowlers' averages. All optional Event's entry must be paid at the time of the bowler's first entry.
4. Bowlers may enter more than once (as space in regularly scheduled squads is available) in each Event. A Team can only qualify for prize monies once in the **TEAM** and **SCRATCH** events. However, a Team with **at least 2 different members** will qualify as a different Team. A bowler must compete with a **different partner** to qualify for prize monies in the **DOUBLES** and **SCRATCH**. A bowler can qualify for prize monies in **SINGLES, SCRATCH** and **ALL-EVENTS** events only once.
5. **ADVANCED REGISTRATION IS REQUIRED.** All entries will be scheduled according to date received by the Tournament Director. No entries will be scheduled without **FULL** payment of **ALL** entry fees. Entry fees will not be refunded after the scheduled squads' start times.
6. **ENTRY FEE.** Each Event is **\$20 per bowler**. (\$9 Lineage + \$2.00 Expenses + \$9.00 Prize Fund). There are additional entry fees of **\$3 per bowler per EACH** optional Event and **\$12/\$15 per team** for the Team Scratch Event: these entry fees are optional and included in Prize Fund. Guaranteed \$400 for team Division 1 and 2. Payout will be one in every 5 entries.
7. **AVERAGES.** Averages shall be the **HIGHEST** adult USBC sanctioned league average of at least 21-games or more for the season (includes sanctioned 2019 summer leagues). If there is no qualified USBC average for 2018-19, a bowler must use the highest average with at least 12-games or more in a current 4-Rivers USBC league, as of the time they bowl, and **ALL 4-Rivers USBC leagues'** standing sheets showing the bowler's current averages and games bowled must be included with the entry or provided at check-in. If an average is not verifiable on **www.bowl.com**, the Official Averages for the 2018-19 Season, or by current leagues' standing sheets, the bowler must use an average of 230 in each Event.
8. **HANDICAPS.** The tournament will use **80%** of the difference between the bowler's average and **230**. Bowlers with an average of 230 or more must use the **scratch** scores bowled in each Event. **NO** bowler will be given a negative handicap.
9. All bowlers must show their current USBC membership card at check-in. Duplicate cards can be printed from **www.bowl.com**. Check-in will begin 30-minutes prior to each squad time. Substitutes must be presented to the Tournament Director prior to check-in.
10. Tardy bowlers will start to bowl in the frame in progress at the time of their arrival. No pins are awarded for missed frames.
11. USBC Rules 300c and 319 will apply. All rules not covered here will be covered by USBC tournament rules.
12. All disputes and protests shall be handled by the Tournament Director. Contact **Sharon Brandhorst, Association Manager** at **636-388-5090** or **association.manager@4riversusbc.com**. The decision of the Tournament Director shall be final unless an appeal is filed within 72 hours in accordance with USBC Rule.
